APPLICATION FOR MEMBERSHIP AND FOR ELECTRIC SERVICE

THE UNDERSIGNED (hereinafter called the "Applicant") agrees to become a member of and agrees to purchase electric energy from SOUTHEASTERN ILLINOIS ELECTRIC COOPERATIVE, INC. (hereinafter called the "Cooperative") upon the following terms and conditions:

- 1. The Applicant agrees, pursuant to this Agreement for electrical service, to purchase electric energy from the Cooperative in accordance with the bylaws and policies of the Cooperative and to pay monthly for all electrical energy supplied by the Cooperative at rates to be established from time to time by the Board of Trustees of the Cooperative; provided, however, that the Cooperative may limit the amount of electric energy to be furnished for industrial uses. The established residential rates include a subscription to any publication of the Cooperative and to the ILLINOIS COUNTRY LIVING MAGAZINE, published by the Association of Illinois Electric Cooperatives or its successor.
- The Applicant will comply with and be bound by the provisions of the charter, bylaws, policies, rules and regulations of the Cooperative as they now exist or may from time to time be adopted or amended by the Cooperative, and further agrees to retroactive application of any such amendments or adoptions.
- 3. Acceptance of the application by the Cooperative shall establish a membership and an Agreement for Electric Service between the Member and the Cooperative. The Agreement for Electrical Service shall continue in force from the date service is made available until canceled by written notice given either party by the other. The membership shall continue in force until either party terminates the membership of the member in accordance with the bylaws and policies of the Cooperative. Removal or disconnection of the meter at any time, whether to discontinue service for collection of an unpaid account or for any other reason, by the Cooperative shall not constitute a breach of either contract.
- 4. The Applicant will grant to the Cooperative rights of way and easements to construct, operate, maintain, improve and extend electric lines on the lands of the Applicant, and in or upon all streets, or highways abutting said lands.
- 5. SOUTHEASTERN ILLINOIS ELECTRIC COOPERATIVE, INC. shall have the right of access to Member's premises at all reasonable times for the purpose of inspecting Member's electrical installation, the installing, reading, inspecting and repairing of the Cooperative's lines, meters, devices or other equipment used in connection with its delivery of electricity, the determination of Member's connected electrical load, the removal of the Cooperative's property and for all other proper purposes deemed necessary by the Cooperative.
- 6. Falsification of any of the following information may result in disconnection of service without notification.
- 7. The Cooperative meter shall constitute the point of delivery to the Applicant and the Applicant will own and maintain all meter bases, poles, wire, equipment and other facilities at or beyond the point of delivery.
- 8. Applicant acknowledges that the Cooperative cannot guarantee continuous, uninterrupted service, and Applicant agrees that the Cooperative is not responsible for damage to Applicant's premises, damages to anything at said premise or any special or consequential damages which may occur from service interruption caused by, but not limited to, acts of nature (for example ice, lightning, flood, tornado, extreme winds, etc.), accidents, sabotage, public enemy, vandalism, or other causes of interruptions in service that are beyond the control of the Cooperative.
